Report: On Jan08 KPRT Political Director Davison and Correctional Services Director Milino paid a visit to the NDS facility in Kandahar in the context of on-going efforts to determine NDS capacity building needs.

Visit to the Detention Areas: Both the old and new detention buildings were visited. In total, along with their father and two detainees are currently being held including minors uncles (none of whom are Canadian-transferred). We spoke briefly to one of the minors and subsequently urged NDS to assess the necessity for their continuing detention. Apart from the presence of the minors, nothing out of the ordinary was seen.


