ICBC is responding to your request for records regarding the BC Care Card.

Please find enclosed the records that are being released. There are 2251 pages in total, however not all of the information is relevant to your request and, therefore, has been redacted.

Although it wasn't requested, we have provided some additional background information on the BC Care Card Project, which you may find helpful in understanding the project. This background information is found in the ICBC Program Model document.

Information has been redacted from the records in accordance with the Act. The enclosed *Requester Report* outlines how the exceptions of the Act have been applied to the records and which pages have been partially severed or withheld entirely. Please note that duplicate records have been marked. The enclosed *Severance Key* outlines the exceptions of the Act.

Under Section 52 of the Act, you may ask the Information and Privacy Commissioner to review ICBC's response to your access request. If you wish to request a review, you must submit a written request (within 30 days of receipt of this letter) to:
