

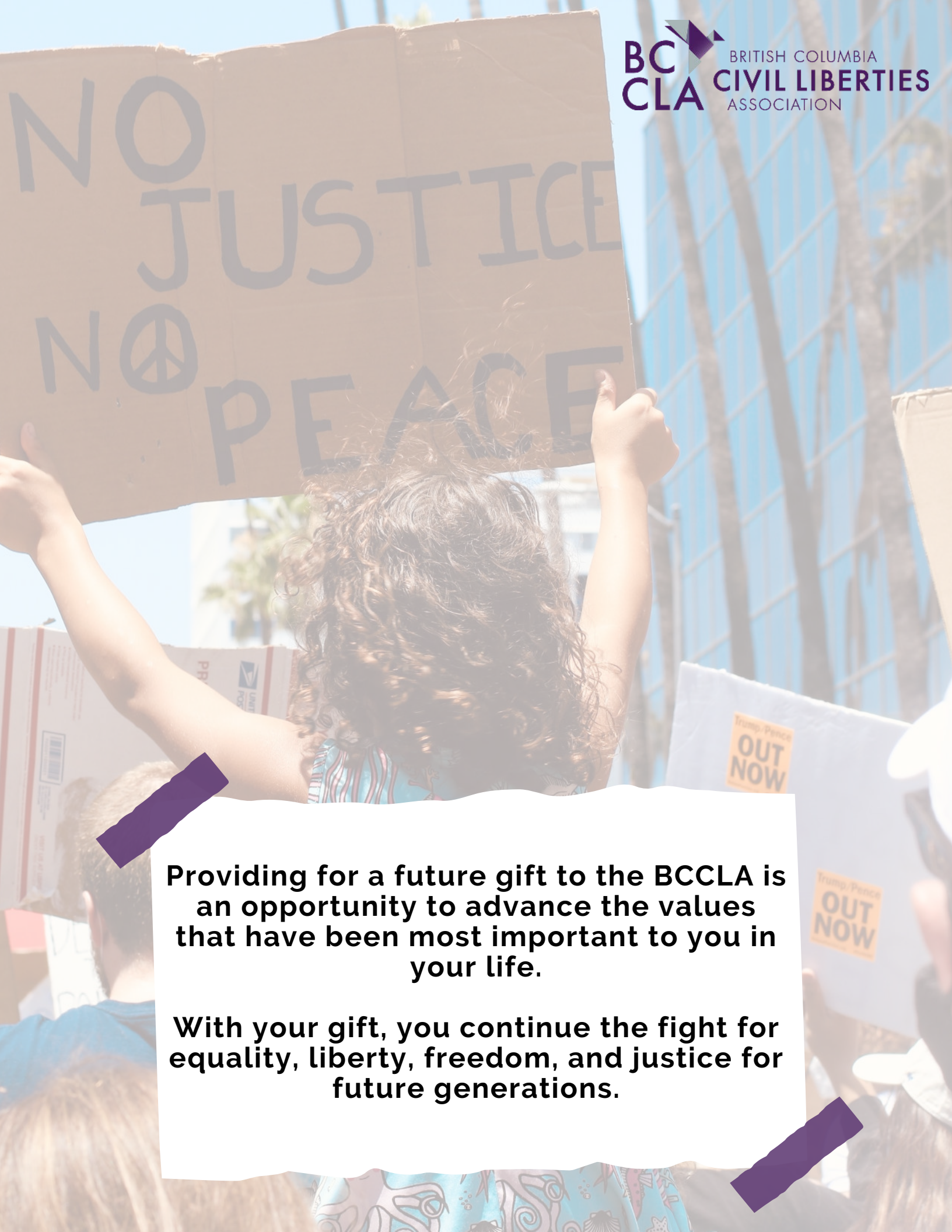

FIGHTING FOR RIGHTS

The BCCLA has a long track record of important successes.

From our landmark victory to end solitary confinement, to our campaign to end immigration detention, we are one of the most vibrant and impactful charitable organizations in the country.

OUR MISSION

Our mandate is to defend and extend civil liberties and human rights in Canada. We achieve our mandate through direct assistance to the public, policy advocacy, community education, and public interest litigation.

The BCCLA is an autonomous, non-partisan charitable society.

We are unaffiliated with any other organization or political group.

OUR WORK

In 2022, we made 27 individual and joint advocacy submissions to government decision makers, we were involved 19 active impact litigation cases and interventions, and sat on at least 6 coalition and government advisory groups, often resulting in active consideration by decision makers of civil liberties and human right issues when drafting policy and law.



LEGACY GIVING

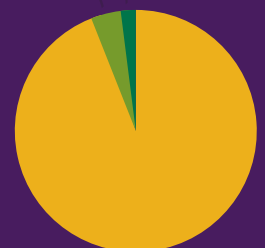

Why our legacy includes the BCCLA

We believe that the BC Civil Liberties Association works to both diligently and effectively advance the cause of human rights and justice for all Canadian citizens.

Because of the complexity of the law and the expense of legal representation and court proceedings, many Canadians can not have justice.

In addition, as the law continually evolves, new grey areas become evident and constant vigilance is necessary to detect new threats to our civil liberties. BCCLA has advocated effectively on these fronts, for example in LGBTQ+ and in assisted dying legislation.

A growing mutual awareness to make deliberate budget choices and to give to others in appreciation of the rich life we enjoy has led us to the understanding that by making legacy gifts we can continue our gifts into the future.

Sample Will clauses

UNRESTRICTED GIFT:

I hereby give the residue of my estate (OR __% of the residue of my estate OR the sum of \$_____) to the British Columbia Civil Liberties Association (BN: 888466844RR0001), if it is in existence at the date of my death, to be used for such purposes as the board of directors of the British Columbia Civil Liberties Association shall decide in their discretion.

RESTRICTED GIFT:

I hereby give the residue of my estate (OR __% of the residue of my estate OR the sum of \$_____) to the British Columbia Civil Liberties Association (BN: 888466844RR0001), if it is in existence at the date of my death, to be used for _____. If unforeseen circumstances make the specified use of this gift no longer practical or desirable, as determined by the board of directors of the British Columbia Civil Liberties Association, the board of directors of the British Columbia Civil Liberties Association may change the terms of the specified use, such change to be in keeping as far as possible with the general intent of this gift.
